What's in these terms?

These terms tell you the rules for using this online valuation tool (the "tool").

Who we are and how to contact us

The tool is provided by Expert Agent (a trading name of Websky Limited) ("**we**"). We are registered in England and Wales under company number 03975262 and have our registered office at The Cooperage, 5 Copper Row, London SE1 2LH.

The website on which the tool appears belongs to the estate agent (the "**agent**"). If you have questions about the tool or the valuations it generates, you should contact the agent using the information available on the agent's website.

By using the tool, you accept these terms

By using the tool, you confirm that you accept these terms of use and that you agree to comply with them.

If you do not agree to these terms, you must not use the tool.

We recommend that you print a copy of these terms for future reference.

There are other terms that may apply to you
