LOCATION

Sun Court occupies a prominent corner position on Wolborough Street, a pedestrianised retail parade in the heart of Newton Abbot town centre. Wolborough Street links directly to Courtenay Street, the town's prime retail location and is home to a mix of national independent traders including Austins Department Store, as well as numerous retailers, catering outlets and professional service providers.

Newton Abbot is a thriving market town, with a population of approximately 30,000. Well located in South Devon and serving much of Southern Dartmoor as a catchment, the town has mainline railway links and immediate dual carriageway access, linking the town to the M5 at Exeter.

DESCRIPTION

Sun Court is a corner located, three storey building of traditional construction arranged as a ground floor retail fronted office unit occupied by a long standing tenant trading as a Letting Agent, with a further commercial retail unit to the side of the property and six self-contained residential flats - 4 x studio flats and 2 x 1 bedroom flats.

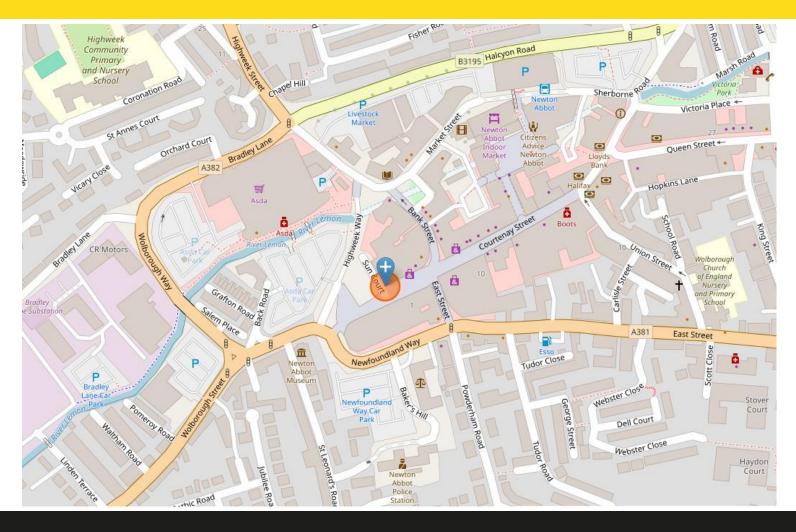
