The 1.25 acre greenfield site is estimated to have space for a potential 900 burial plots and the initial infrastructure incorporating an 18 space carpark, first phase footpaths and perimeter fencing, entrance gate and equipment shed have all been constructed. PLANNING CONSENT

Planning was submitted under application reference 11/00131/FUL and consent was granted 25th January 2012 under reference APP/X4725/A/11/2161984. Planning consent allowed change of use from unoccupied greenbelt land to cemetery to include an 18 space carpark. It should be noted that consent includes restrictions on opening hours and height of markings / headstones. SIZE

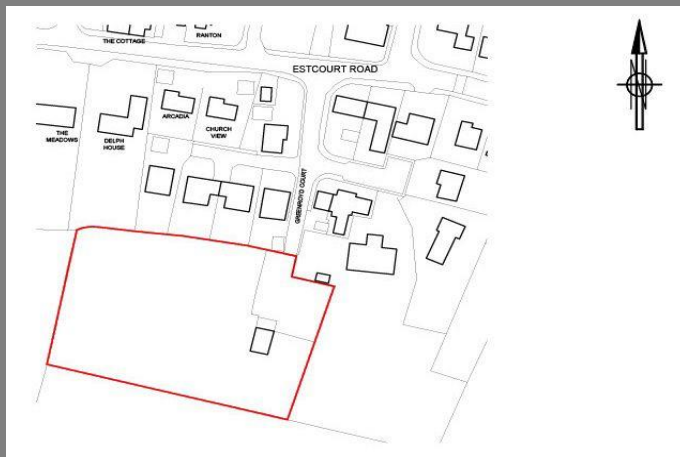
