This wonderful family home's sense of grandeur is evident in the large, high-ceilinged rooms, continuing to the first floor where you'll find an expansive master bedroom with a dressing room and a luxurious ensuite bathroom. There are four further double bedrooms, along with a spacious family bathroom. Outside, the property boasts a formal lawn, a gravelled driveway with ample parking, wonderful walled courtyard and a detached double garage with a workshop at the rear, all adding to the allure of this exceptional residence.
