A semi-detached property with three bedrooms offered for sale by way of The Modern Method of Auction. This family home is situated in a popular residential area local to a range of amenities and a short distance from Gornal Village.

The property requires modernisation works but offers great potential and must be seen to be appreciated. Noteworthy features include: two reception rooms, kitchen, bathroom, separate WC, three first floor bedrooms, part double glazing, driveway for ample off road parking and a good size rear garden with patio areas and useful out building.
