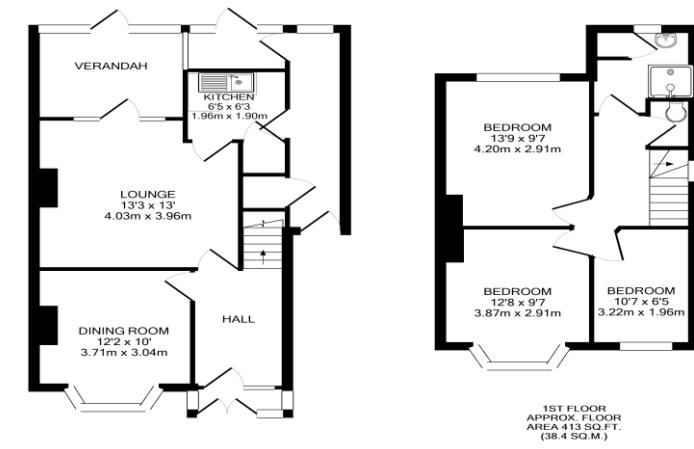
The rear garden is laid to lawn. The front garden is also laid to lawn with a partially lowered dropped curb offer the potential of a driveway
