The property is entered via a uPVC double glazed door into a welcoming entrance hallway with loft access, laminate flooring, and doors leading off to all rooms.


The kitchen/diner overlooks the rear garden and is fitted with a range of wall and base units, complementary worktops, tiled splashbacks, a stainless steel sink with drainer, and space for cooking appliances. There is an

integrated fridge and freezer, plumbing for a washing machine, and a wall-mounted boiler. The lounge is light and spacious, featuring solid wood flooring and French doors that open onto the enclosed rear garden—perfect for relaxing or entertaining. Both bedrooms are generous doubles. Bedroom one includes fitted wardrobes and laminate flooring, while bedroom two offers a built-in

wardrobe and views to the front aspect. The bathroom is fitted with a panelled bath and shower over, low-level WC, pedestal wash hand basin, heated towel rail, tiled flooring, and splashback.

Externally, the property enjoys a low-maintenance rear garden with patio area, decorative stone chippings, and a garden shed. The front garden is mainly laid to lawn with hedge boundaries, a driveway providing off-road parking, and side access to the rear.


