Doors to lounge, kitchen, under stairs storage cupboard, radiator, radiator.

Double glazed bay window to the front, television point, radiator, door to dining room.

DINING ROOM

Double glazed double doors to the rear, radiator, door to lounge.

KITCHEN

Double glazed window to the rear, radiator, integrated oven and hob with extractor hood over, door to garage, ceramic tiled flooring, a range of base and eye level units with rolled edge work surface over, integrated dishwasher, space for fridge freezer.

LANDING

Double glazed window to the side, doors to bedrooms 1, 2, 3 and bathroom, access to loft void, boiler cupboard.

BEDROOM ONE

Double glazed window to the front, radiator, built in wardrobe.

BEDROOM TWO

Double glazed window to the rear, radiator, built in wardrobe.

BEDROOM THREE

Double glazed window to the front, overstairs cupboard, radiator.

BATHROOM

Two opaque double glazed windows to the rear and side, a three piece suite comprising a panelled bath, wash hand basin, low level w.c., ceramic tiled flooring, heated towel rail, ceiling downlights, fully tiled walls, extractor fan.

GARAGE

Up and over door with power and lighting, off road parking, plumbing for washing machine, double glazed window to the rear, UPVC double glazed door to garden.

FRONT GARDEN

Shingled area, shrubbed area.

REAR GARDEN

Patio area, laid to lawn, courtesy door to garage.


