Proceed at of Bury via Fornham Road, at the traffic lights turn left onto Tollgate Lane and take the right hand turning onto Lancaster Avenue and immediate left on to Northumberland Avenue. Turn left in to St Olaves and then right in to Hunter Close. Summers Road is on the right hand side and the property can be found on the left.

Location

The historic market town of Bury St Edmunds provides an extensive range of shopping facilities, including the Arc Shopping Centre. There are also excellent educational, recreational and cultural facilities and for those needing to commute there is convenient access to the A14, which provides links to Cambridge, Ipswich and London / Stansted Airport via the A11/M11. The railway station at Bury St Edmunds offers a link to mainline services to London Liverpool Street and Kings Cross.

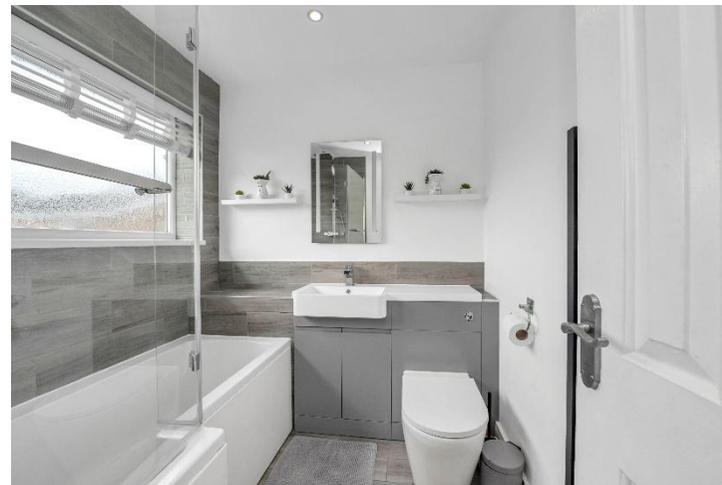

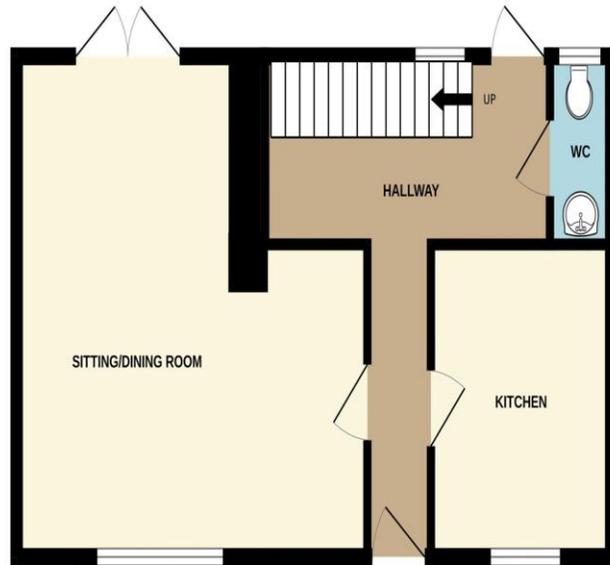

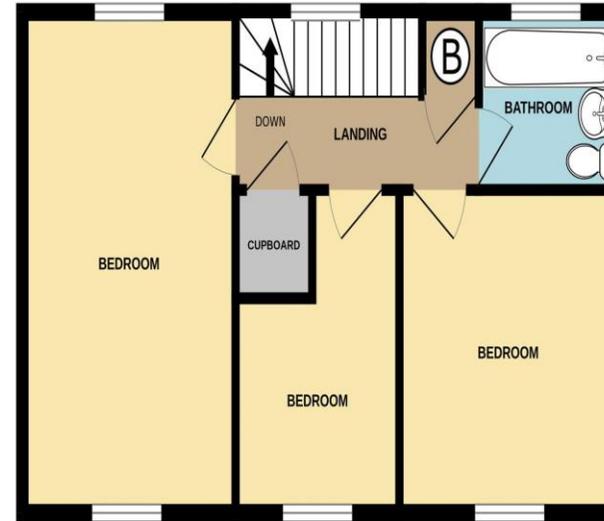
