**** RARE LAKEFRONT LODGE on a LARGE CORNER PLOT ****

This 2010 Willerby Boston 40 x 20 is a two bedroom luxury lodge with spacious open plan kitchen/diner with the lounge area looking out over the lake. There are two double bedrooms, the principal features an En-suite shower room and dressing area, the second has a large walk-in wardrobe.

The main bathroom houses a bath with shower over, vanity unit and low level WC. There is a copious amount of storage inside the lodge which is a great addition.

Outside, there is parking for up to three vehicles, a grassed area and a wrap around veranda which looks out over the lake where you can sit and relax whilst watching the sun setting.

Oaklands Holiday Park is open 50 weeks of the year and features a fabulous bar/club house which hosts events throughout the season, a well stocked convenience store and is ideally located for countryside walks and just a short drive to the beach

Carpet flooring, double fitted wardrobe.

BEDROOM TWO

9' 8" x 9' 1" (2.94m x 2.77m)

Window to side, carpet flooring, centre light, radiator, walk-in fitted wardrobe (6'7" x 3'11"), heater.

FAMILY BATHROOM

6' 9" x 5' 6" (2.06m x 1.68m)

Obscured window to side, grey laminate flooring, centre light, radiator. Panelled bath with shower over, low level WC and vanity unit.

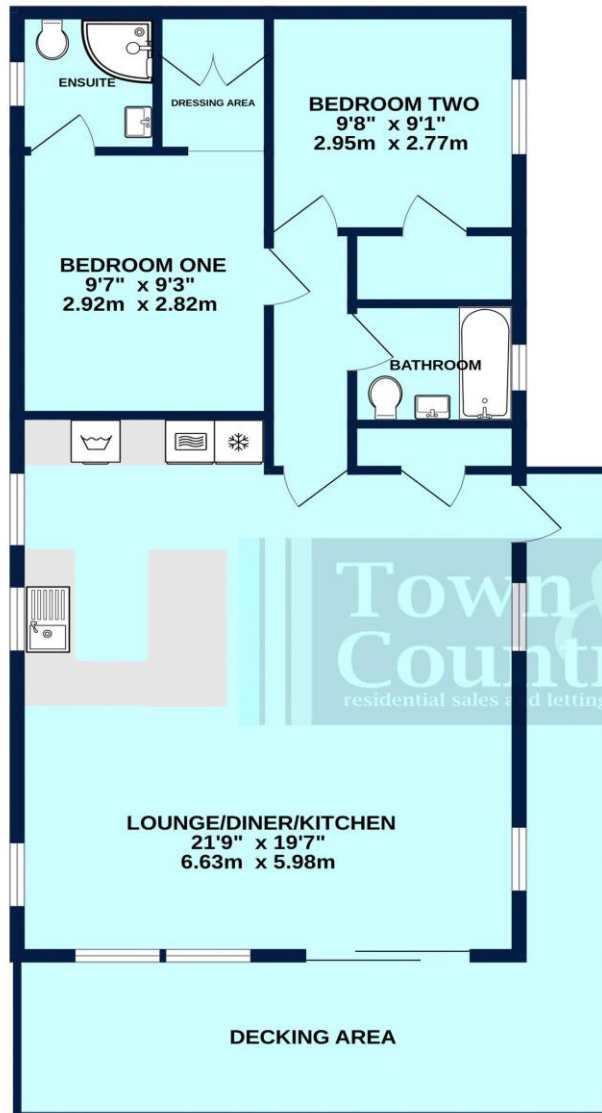
EXTERIOR
