Entrance Hall

Entering the property reveals a radiator, laminate flooring and access to the storage cupboard.

Lounge/Diner

21' 9" x 10' 10" (6.62m x 3.30m)

The lounge-diner has dual aspect windows to the front and rear elevation, two radiators and a carpeted floor.

Kitchen

11' 8" x 6' 6" (3.56m x 1.99m)

The kitchen has a window to the rear elevation, a radiator and vinyl flooring. There are also fitted units with a sink and drainer and plumbing for a washing machine.

With vinyl flooring and a door to the rear garden.

The WC has an opaque window to the rear elevation, vinyl flooring, a WC and a basin.

With access to the loft, a storage cupboard and a carpeted floor.

Bedroom One

Bedroom one has a window to the front elevation, a radiator and a carpeted floor.

Bedroom Two

Bedroom two has a window to the front elevation, a radiator and a carpeted floor. There is also a built in cupboard.

Bedroom Three

8' 10" x 7' 11" (2.69m x 2.42m)

Bedroom three has a window to the rear elevation, a radiator and a carpeted floor. There is also a built in cupboard.

Wet Room

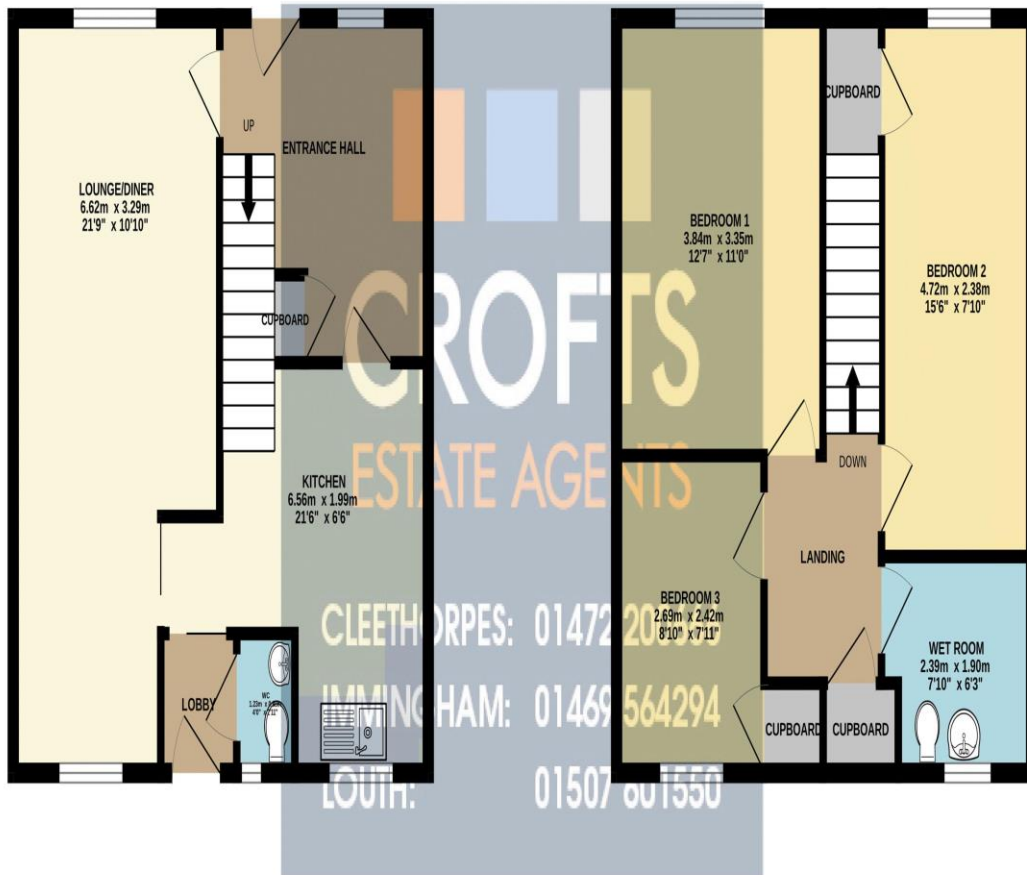
