LOCATION

Within Stoke sub Hamdon there is a variety of local shops, mini supermarket, hairdresser, chemist, veterinary surgery, doctors, dentist, post office, public houses, social club, garage, coffee shop and bus services as well as primary and secondary schools.

The local beauty spot of Ham Hill stands on the fringe of the village offering commanding views over the surrounding countryside.

Yeovil lies approximately 6 miles to the East, Ilminster approximately 10 miles to the West. Excellent road access via the A303.

Approach

This property is set back from the road and there is a path running along side the graveled parking area at the front of the property to the front door.

Ground Floor Living

Stepping through the UPVC front door, you are welcomed into a bright **hallway**, where the staircase rises to the first floor.

The hallway also benefits from useful under-stairs storage, a wall-mounted radiator, and doors leading to the principal ground-floor rooms.

Kitchen – Fitted with a range of wall and base units, this well-proportioned kitchen offers space for a large gas Rangemaster-style cooker with hob above, a full-height fridge-freezer. A rear-aspect window and a door provide views and direct access to the garden.

A partially glazed door leads through to the: **Living/Dining Room** – A spacious and versatile room featuring ample space for a dining table to comfortably seat six or more. A charming log burner creates a warm focal point, while dual-aspect windows ensure plenty of natural light. This room also includes two radiators and a door leading to the **Utility/WC** - Room for a washing machine and tumble dryer and there is also a useful downstairs

wc.

First Floor Living

Ascending the stairs to the first floor, the landing provides access to all bedrooms and the family bathroom.

Bedroom 1 – A spacious double bedroom with a rear-aspect window, radiator, and ample space for extensive storage.

Bedroom 2 – A well-proportioned room with a rear-aspect window and radiator.

Bedroom 3 – A front-aspect bedroom featuring a radiator. **Family Bathroom** – A modern, fully tiled bathroom comprising a bath with shower over, front-aspect window, heated towel rail, vanity unit with hand wash basin, and WC.

Landing – Offers access to the loft and includes a useful airing cupboard.

Garden and Parking

At the front of the property, there is off-road parking for up to four vehicles, complemented by a lawned area.

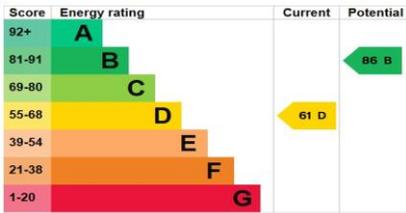
To the rear, the home boasts an exceptionally large, fully enclosed garden, predominantly laid to lawn.

The outdoor space also includes a brick outbuilding, a garden shed, and a dedicated vegetable patch situated at the top of the garden.
