The Reservation Fee is paid in addition to purchase price and will be considered as part of the chargeable consideration for the property in the calculation for stamp duty liability. Buyers will be required to go through an identification verification process with iamsold and provide proof of how the purchase would be funded. Description: A two bedroom semi-detached bungalow offering no upward chain in need of full modernisation. Comprising of porch, two reception rooms, kitchen, two bedrooms and a wet room. Externally there are front and rear gardens, garage and driveway
