



Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO₂). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO₂ emissions.

An average household produces

6 tonnes of CO₂

2.4 tonnes of CO₂

This property's potential production

0.7 tonnes of CO₂

By making the recommended changes, you could reduce this property's CO₂ emissions by 1.7 tonnes per year. This will help to protect the environment.
