

## Breakdown of property's energy performance

### Features in this property

### Primary energy use

The primary energy use for this property per year is 229 kilowatt hours per square metre (kWh/m<sup>2</sup>).

### How this affects your energy bills

An average household would need to spend **£1,877 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

You could **save £462 per year** if you complete the suggested steps for improving this property's energy rating.
